## Cities Scoring Methodology Changes 2025

#### Introduction

This document highlights changes to CDP's scoring methodology for the Cities questionnaire. The document indicates the main changes that have occurred between 2024 and 2025 in the respective scoring bands. In 2025, few changes have been made and mainly center around improving methodology clarity and updating year requirements, rather than increasing ambition. A summary of the rationale for these changes is provided.

This scoring methodology changes document is intended to provide guidance to cities in relation to how their response will be scored in 2025. In common with other scoring processes of this type, we expect to make future adjustments, during the disclosure cycle, to optimise the clarity of the scoring methodology in context of responses received.
